COMMITTEE ON GROUNDS AND BUILDINGS

March 15, 2000

The Committee on Grounds and Buildings met on the above date at UCSF - Laurel Heights, San Francisco.

The meeting convened at 8:30 a.m. with Committee Chair Lee presiding.

1. **APPROVAL OF MINUTES**

Upon motion duly made and seconded, the minutes of the meeting of January 19, 2000 were approved.

2. **REPORT OF THE CHAIRMAN**

Committee Chair Lee reported that the design review committee had studied the recommendations in detail. He noted that the designs for student housing on the Los Angeles and Irvine campuses were of particular merit.

3. CONSENT AGENDA

A. Approval of Design, Seismic Safety Corrections, FEMA Program Phase 1: Barrows Hall, Hildebrand Hall, Latimer Hall, and Silver Space Sciences Laboratory, Berkeley Campus

The President recommended that the Committee:

(1) Adopt the Findings.

(2) Approve the design of the Seismic Safety Corrections, FEMA Program Phase 1: Barrows Hall, Hildebrand Hall, Latimer Hall, and Silver Space Sciences Laboratory, Berkeley campus.

B. Approval of Negative Declaration and Approval of Design, Undergraduate Housing Expansion, Phase 2–Mesa Court, Irvine Campus

- (2) Adopt the Findings, Statement of Overriding Considerations, and Mitigation Monitoring Program.
- (3) Approve the design of the University Village Expansion project, Los Angeles campus.

It was noted that Regents had been provided copies of a communication from two residents of the neighborhood bordering the University Village Expansion who expressed concerns about the increase in traffic that the project will cause.

D. Approval of Negative Declaration and Approval of Design, Parnassus Services Seismic Replacement Building, San Francisco Campus

The President recommended that, upon review and consideration of the environmental consequences of the proposed project as indicated in the Initial Study, the Committee:

- (1) Approve the Tiered Initial Study/Negative Declaration.
- (2) Adopt the Findings.
- (3) Approve the design of the Parnassus Services Seismic Replacement Building, San Francisco campus.

- (2) Adoption of the Findings, Statement of Overriding Considerations, and Mitigation Monitoring Program.
- (3) Amendment of the Long Range Development Plan.
- (4) Approval of the design of the Engineering-Science Building, Santa Barbara campus.
