TRIP Transition and Implementation Update

- TRIP transition began on August 1, 2013
 - New long-term policy allocations
 - \$500 million transfer from STIP
- Most significant allocation changes
 - Core IG Credit reduced allocation to 7.5%, was 45%
 - Creation of new Alternatives and Opportunistic Equity allocations
 - 10% Absolute return
 - 20% Cross Asset Class (CAC)
 - 10% Opportunistic Equity
- Transition 80% complete as of September 30, 2013
 - CAC at 10%, goal is 20%
 - Total of \$1.7 billion transferred from STIP to TRIP through November 1, 2013
- Cost of transition for the quarter ending September?
 - TRIP actually outperformed its benchmark by 16 bps
