
Application for 2019-20 Student Regent University of California

The Student Regent

The Student Regent is a full voting member of the Board of Regents of the University of California, attending all meetings of the Board and its Committees and serving a one year term commencing July 1, 2019. The Student Regent serves as a trustee on behalf of the people of the State of California while bringing the voice of the students to the Board. From the time of appointment as a Student Regent in July 2018, but prior to the commencement of service as a member of the Board in July 2019, the appointee holds the title Regent-designate and is invited to participate in all meetings of the Board and of its Committees, but without a vote.

The Regents of the University of California

The Organic Act of 1868 established the University of California and entrusted its organization and governance and legal and corporate authority to an independent corporation, The Regents of the University of California. California voters amended the State Constitution in November 1974 to provide the Regents with the option of appointing a student to serve as a member on the Board of Regents. Every year since 1975, a University student has served as a member of the Board of Regents. The Board of Regents appoints the Student Regent on the recommendation of its Special Committee to Select a Student Regent. The Board of Regents consists of 26 members: 18 are appointed by the Governor for 12-year terms; one is the student appointed by the Regents to a one-year term; and seven, including the President of the University, are ex officio members. The State Constitution provides that Regents shall be persons broadly reflective of the economic, cultural, and social diversity of the State. The Board of Regents operates through six standing committees and a varying number of subcommittees and special committees. The Board and its Committees meet six times a year, every other month. Some committees hold off-cycle meetings.

Duties of The Regents

The Regents establish policy in areas such as long range planning, student fees, admissions, and compensation. The duties of The Regents include overseeing the financial management of the University, as well as appointing the President of the University, the ten campus Chancellors, and the Officers of The Regents. The Regents have delegated a broad range of authority and responsibility to the President of the University and have delegated authority to the faculty in matters relating to educational programs including the establishment and supervision of all courses and curricula.

Qualifications

At the time of application, a candidate for Student Regent must be an undergraduate, graduate, or professional student in good standing at one of the University's ten campuses. During the time a Student Regent serves as a Regent-designate and as a Regent, the student must be enrolled as a student in good standing at a campus of the University of California for each regular term. The Student Regent may not simultaneously serve in any appointed or elected student government position or on the Board of Directors of the University of California Student Association. The Student Regent is not eligible for reappointment to the position, but may serve as Student Advisor.

Remuneration

The Student Regent is reimbursed for expenses incurred for attendance at meetings of the Board and its Committees. The Student Regent shall have the option of receiving either a fee waiver or a scholarship in an amount equivalent to the student's total mandatory University fees and tuition during the two academic years of service as a Regent-designate and as a Regent. At the time of appointment, the Student Regent is provided with a furnished, equipped office at his or her home campus.

Student Regent Selection and Application Process

Student Regent Selection Process

Each application for student Regent will be reviewed in March 2018 by a regional nominating commission. There are two commissions: the Southern Regional Nominating Commission, comprised of students representing the Irvine, Los Angeles, Riverside, Santa Barbara, and San Diego campuses, and the Northern Regional Nominating Commission, comprised of students representing the Berkeley, Davis, Merced, San Francisco, and Santa Cruz campuses. Applicants selected will be interviewed on Sunday, April 8, 2018.

The Southern Commission will select 5 semifinalists and the Northern Commission will select 5 semifinalists who will be interviewed on May 4, 2018 by the Board of Directors of the University of California Student Association. References named by the ten semifinalists will be asked to submit letters of reference prior to the interview with UCSA.

UCSA will select three finalists whose names are forwarded to the Secretary and Chief of Staff to The Regents. The three finalists' Chancellors will be contacted to comment on their qualifications. The finalists will be interviewed later in May by the Regents' Special Committee to Select a Student Regent, which will recommend appointment by the Board of Regents at its July 2018 meeting.

Applicants can submit for reimbursement only for in-state mileage costs to the first interview and in-state mileage or in-state airfare to the second and third interviews.

Application for 2018-19 Undergraduate Student Advisor to the Regents University of California

The Student Advisor to the Regents

In January 2016, the Board of Regents approved a two-year pilot program creating a non-voting position of Student Advisor to the Board of Regents beginning in July 2017. The purpose of the program is to provide balance in the student perspective to complement the perspective of the Student Regent and better inform the Regents of the range of issues facing students. The Student Advisor is selected from a segment of the student population not represented by the Student Regent during the same term of service. The Student Advisor is appointed for a term of one year. In 2018-19, because the Student Regent will be a graduate student, the Student Advisor must be an undergraduate.

Qualifications

At the time of application, a candidate for Student Advisor must be an undergraduate, graduate, or professional student in good standing at one of the University's ten campuses. During the period of service, the Student Advisor must be enrolled as a student in good standing at a campus of the University of California for each regular term. If the Student Regent is an undergraduate, the Student Advisor must be a graduate or professional student and vice versa. In 2018-19 the Student Advisor must be an undergraduate. Neither Student Regent nor Student Advisor may simultaneously serve in any appointed or elected student government position or on the Board of Directors of the University of California Student Association. Neither a Student Regent nor a Student Advisor is eligible for reappointment to the same position. A Student Advisor may be eligible to later serve as Student Regent.

Remuneration

The Student Advisor is reimbursed for expenses incurred for attendance at meetings of the Board and its Committees. The Student Advisor receives no other benefits.

Undergraduate Student Advisor Selection and Application Process

Student Advisor Selection Process

Each application for Student Advisor will be reviewed in March by a Student Advisor Nominating Committee comprised of: (1) a student body president; (2) a UCSA representative; (3) a staff member from Student Affairs at UCOP; (4) a campus Dean of Student Affairs; and (5) the sitting Student Advisor.

The candidates selected by the Nominating Committee will be interviewed by the Nominating Committee in April 2018.

The Nominating Committee will select no more than three candidates for a final interview with the Chair of the Board and the Chair of the Governance and Compensation Committee.

References named by the candidates selected for interviews will be asked to submit letters of reference in mid-April. The finalists' Chancellors will be contacted to comment on their qualifications.

The Chair of the Board and the Chair of the Governance and Compensation Committee will interview the Student Advisor candidates in late May **after** the Regents' Special Committee on the Selection of a Student Regent has selected the Student Regent-designate.

The Student Advisor will assume office on July 1, 2018.

Applicants can submit for reimbursement for in-state mileage costs or in-state airfare, whichever is appropriate, to cover the costs of their travel to the interviews.
