UC Health Fiscal Year 2021-22 Report on Covered Affiliations

As of June 30, 2022

In July 2021, the Board of Regents approved *Regents Policy 4405: Policy on Affiliations with Healthcare Organizations that Have Adopted Policy-Based Restriction on Care*, which governs affiliations between health care organizations that have policy-based restrictions on care and the University, including University of California Health's (UCH) academic health centers (AHCs) and health professional schools. The Regents Policy and an accompanying systemwide policy providing implementation direction, the *Interim Policy: Affiliations with Certain Healthcare Organizations*, released in September 2021, together are intended to protect the ability of UC clinicians and trainees working at those organizations ("covered affiliates") to provide evidence-based, appropriate care to all patients.

To promote complete and consistent adoption of the policies at each location, UC Health convened a working group comprised of representatives from each UC Health location. This group coordinated with sub-groups, committees, leadership, and individuals at each location to implement and operationalize measures within the policy. This report provides a status on the development and implementation of consistent practices, draft reporting, model communications, and establishment of governance as required by the policies.

Implementation Update July 1, 2021 – June 30, 2022

The following outlines the status of implementation efforts for Fiscal Year 2021-22 (FY21-22). An overview of all requirements and implementation status is also available in <u>Appendix A</u>.

- 1. **Moratorium on New Non-Compliant Agreements** Effective July 1, 2021, the University implemented a moratorium on all new agreements with covered affiliates that were not in compliance with the Regents Policy.
- Systemwide Policy Review: The Interim Policy: Affiliations with Certain Healthcare Organizations was released in September 2021 providing implementation direction for Regents Policy 4405. The review period for the interim policy closed on June 25, 2022. The feedback is under review, consistent with the systemwide process for policy development.
- 3. Affiliation Agreements The interim systemwide policy includes a due diligence checklist that must be completed before entering into an agreement with a covered affiliate and requires new approval processes to ensure all new and renewed contracts align with the Regents policy. All UC Health locations have implemented these requirements.
- 4. Contract Amendments All agreements with covered affiliates must comply with the Regents and interim systemwide policies or be terminated by December 31, 2023. The interim policy includes new non-discrimination contracting language, and UC Legal continues to negotiate with covered affiliates to amend existing contracts and ensure compliance with the policies. Significant progress has been made to update agreements with the Dignity/CommonSpirit Health, Adventist Health, and Providence Health systems. Efforts continue with other covered affiliates and any arrangements that are not brought into compliance by December 31, 2023 will be terminated.

5. **Communications** – Model language and guidance have been developed for use by the AHCs and health professional schools in communicating with their patients, faculty, staff, and trainees as required by the policies. These materials are intended to raise awareness of the policy-based restrictions on care at partner organizations and patients' options for care.

Model language for patients that can be used on AHC web pages and in talking points about affiliations and the transfer process was provided to each location. Sites are incorporating the language on their websites and in their transfer processes.

Communication language for faculty, staff and trainees was distributed to each health campus to plan for local implementation. The communication expressly conveys the University's expectation that UC personnel and trainees make clinical decisions consistent with the standard of care and their independent professional judgment.

Through these efforts, health professional school administrators and faculty members have identified challenges to identifying alternate sites with the faculty, resources, and clinical/educational experiences needed to assure compliance with ACGME, specialty Board, and institutional requirements, while maintaining an equitable experience for all trainees in a program that is heavily dependent on a covered affiliate such as the VA Health System. Given these concerns, the details of the model communication are currently being reviewed together with the systemwide policy, and once finalized, all locations are prepared to distribute through various channels and incorporate the information into ongoing communication and training processes.

- 6. Complaint Resolution Each UC Health location identified complaint resolution contacts listed in <u>Appendix B</u> and developed processes for receiving, evaluating, and resolving complaints or grievances from patients, trainees, and personnel related to care received or provided at covered affiliates as follows:
 - a. Reviewed channels and processes for receiving complaints or grievances from UCH patients, trainees, faculty, and staff related to care received or provided at covered affiliate facilities, identified contacts responsible for evaluating and reporting on complaints, and identified a point of contact at UC Health locations to whom UC personnel and trainees can reach out to for assistance if they believe their contractual rights are being impeded.
 - b. If received, concerns raised about impediments to accessing reproductive health care, gender affirming services, or end-of-life care will be escalated promptly to the Chief Executive Officer or designee.
- Reporting The policies require an annual report on covered affiliations be delivered to the Regents. In order to enable consistent reporting, the working group identified reporting requirements and locations implemented processes to capture required data, utilized standard report templates, and performed multiple tests of the reporting process.

A preview of the annual report was shared with the UC Joint Clinical Advisory Committee on Covered Affiliations and the UC Regents Health Services Committee in June 2022.

Appendix C includes reporting on the following, as required by policy:

#	Description of Report
1	New/Extended Affiliation Agreement Report: Each UC Health location implemented systems to identify and consistently report on new, extended, expired or terminated affiliation agreements. Each location confirmed it is reviewing, monitoring and tracking covered affiliations.
2	Complaints Report: Each UC health location identified complaint reporting contacts and processes to receive and evaluate complaints or grievances. As of June 30, 2022, the systems have been tested and concerns were routed through the identified contacts, but when adjudicated, no complaints were identified from patients, faculty, and students regarding their ability to provide or receive care under a covered agreement.
3	Quality Indicators Report: UC Health locations developed a framework to monitor the quality of care provided at covered affiliates and report on standardized quality indicators. This framework includes the UC Health Covered Affiliations Quality Metrics Scorecard to measure publicly available data and assessment of complaints and grievances. In this first year, the annual report will include definitions of these quality indicators and in subsequent years, the results will be reported. At the June Health Services Committee meeting, Regents requested expanding the metrics to measure compliance with the expectations of the policy. Reproductive and sexual health professionals at the University have begun identifying quality and access

measures including a phased approach to gathering this information to support development of a baseline as there is currently very limited publicly available data concerning access to these services at hospital facilities. Further details are available in section 9.

4 **Non-Compliant Agreements:** All UC health locations have implemented new due diligence procedures and are negotiating amendments to existing agreements using compliant language. Per policy, locations have through December 31, 2023 to amend contracts or terminate non-compliant agreements.

The President of the University and Chair of the Health Services Committee are notified of any anticipated changes in existing relationships as a result of the implementation of the policies.

8. Patient Transfer Process

A working group on patient transfers developed procedures to support the transfer of UC patients who require access to a restricted service from a covered affiliate's facility to a UCH or other location where the service can be provided. UCH locations are amending new and existing agreements with covered affiliates to outline expectations regarding these transfers. They also developed communications for UC personnel and trainees to be informed of the transfer process, and to inform patients about restrictions on care and alternative options at UCH or other facilities.

9. Quality Metrics

A framework to monitor the quality of care provided at affiliate sites has been developed to facilitate reporting on measures consistent with the Regents and systemwide policies as listed in <u>Appendix D</u>. In this first year of implementation, UC Health defined quality standards for hospitals that align with the quality domains of the Institute of Medicine¹. The UC Health Covered Affiliations Quality Metrics Scorecard measures the quality of care at covered affiliations using publicly available data and aligns with quality scorecards in use at UC Health locations. These consistent measures will provide the ability to measure care across affiliates and UC hospitals to assess standards of care. The locations have defined this framework and will begin reporting on performance as part of the annual report to the Regents in 2023.

Additionally, at the Regents Health Services Committee meeting in June 2022, Regents requested expansion of the proposed quality metrics to better measure compliance with the expectations of the Regents Policy. Workgroups of health care quality experts and reproductive and sexual health professionals at the University have begun identifying quality and access measures that can help test whether the outcomes of these affiliations align with the expectations of the Regents Policy, in particular that 1) access to restricted services is maintained or improved and 2) necessary and appropriate emergency services can be provided at the affiliate locations.

Reporting on reproductive and sexual health is particularly challenging due to limited publicly available data, and there is pressing need to further protect the data of patients given the current and evolving climate on access to legal and safe abortions, particularly for those from care-limiting states. A phased approach for collecting these data should be considered to support development of baseline measurements while continuing to assess and develop possible additional quality and access measures. UC Health will continue to partner with the Regents, reproductive and sexual health professionals, and affiliates to identify data sources that can further test whether the outcomes of the policy are being met while upholding patient privacy and confidentiality.

10. Joint Clinical Advisory Committee on Covered Affiliations

The Executive Vice President for UC Health and the Chair of the Academic Senate co-chair the Joint Clinical Advisory Committee on Covered Affiliations to review reports on affiliations, solicit feedback from stakeholders, and provide input on UCH policies on covered affiliations.

Per policy, members of the committee include:

- the Executive Vice President for UCH or designee;
- the Academic Senate Chair or designee;
- the Chief Medical Officer of each UC academic health system or designee;
- an Academic Senate appointee who is an active (at least 0.5 FTE) clinician from each campus with an academic health system; and
- three additional members selected by the President not representing either UCH or the Academic Senate.

The committee launched in June 2022 and plans to meet three times a year as required by agenda items and to support the review of the annual report to the Regents Health Services Committee in August.

11. Audit of Affiliations by Ethics, Compliance, and Audit Services (ECAS)

The policies require that ECAS conducts an audit of an appropriate sample of contracts with covered affiliates to ensure their adherence to the contracting guidelines after the December 2023 deadline. ECAS will include the audit on covered affiliations in the annual audit schedule reported to the Regents. In this first year of implementation, ECAS anticipates performing an interim audit to be launched in December 2022.

APPENDIX C: Report on Covered Affiliations through June 30, 2022

The following is the first annual UC Health Report on Covered Affiliations, which includes data on covered health affiliations from July 1, 2021 through June 30, 2022 and for presentation to the Regents Health Services Committee in August 2022.

The report includes data from July 1, 2021, through June 30, 2022. Section I includes a summary of data on covered affiliations and Section II provides details on each new, renewed, expired, or terminated agreement.

I. SUMMARY OF COVERED AFFILIATIONS

The University of California implemented a moratorium on new non-compliant health agreements with covered affiliates on July 1, 2021. All UC Health locations are now utilizing policy-compliant language in new and renewed agreements and will continue to amend all existing contracts through December 31, 2023. The following tables provide summary data on covered affiliations, detailed information can be found in Section II.

Outlined in **Figure 1**, UC Health locations have entered into **36 new policy-compliant agreements and renewed 64 existing agreements with policy-compliant language**. They have also allowed **21 agreements to expire**, 18 of which were under negotiation at the time of this report, and 3 of which the department did not seek to renew. **One agreement** was terminated early and replaced with a new policy-compliant agreement.

NEW/RENEWED AGREEMENTS
